Sub: Reduction of Cargo wise OSBD Norms for Handling Dry bulk cargo-Levy of Penalty and awarding incentive Ref: Secretary Lr. No. IGAD/BDS/SBM-I &BM-3/2018-19 Dt. 6.12.2018

a) Board vide its resolution NO. 114/2018-19 has resolved to approve for proportionate reduction of OSBD Norms on pro-rata basis when less number of hooks are offered i.e., cargo to be loaded/un-loaded at VPT in less than 4 hatches only..

For E.g.- The OSBD Norm fixed for Manganese ore is $8000\ \mathrm{Tons}$. This was fixed presuming that the vessel works with 4 hooks

If a Manganese ore vessel arrives at VPT for discharging from 2 hatches only then the norm will be as follows.

8000÷4 = 2000 Tons per hook

2 Hooks = 2000×2 =4000 Tons

Hence the OSBD Norm for such vessels shall be taken as 4000 Tons. Similarly if a Manganese ore vessel arrives to discharge cargo from 3 hatches only, then norm shall be 6000 Tons. The same analogy is applicable to all the dry bulk/break bulk cargoes handled at VPT berths

b))Board resolved to approve as and when vessels arrive with cargo/to load cargo in 4 hatches at VPT ,but agents opts to work with less number of hooks , The Norm fixed for 4 hatches shall be reckoned for calculating incentive/penalty, but not on the less number of hooks engaged.

In light of the above, It is requested to adhere to the revised instructions strictly.
