All port users are hereby informed that Visakhapatnam Port Trust Board in the Board Meeting held on 28.11.2018 vide Agenda item No. S-12 and vide its Resolutions No. 109 / 2018-19, resolved to modify the Wharf demurrage charges levied on cargoes not removed from the wharf, in table of the SOR at note 6 under clause 4.6.2 ( b) as follows :-


Demurrage on Cargo Not removed from Wharf

Demurrage shall be levied on cargoes not removed from any berth in the Port after completion of discharge from a vessel / shipment to a Vessel / Barge.

S.L. No.	Description	Amount
1.	First 5 Hours	Free
2.	6 <sup>th</sup> to 10 <sup>th</sup> Hour	Free – subject to limiting the free time from 6 <sup>th</sup> hour to 10 <sup>th</sup> hour or berthing of subsequent vessel, whichever is earlier. Thereafter, Rs. 5000 per hour or part thereof will be charged in this slab.
3.	11 <sup>th</sup> to 15 <sup>th</sup> hour	5000 per hour or part thereof
4.	16 <sup>th</sup> to 20 <sup>th</sup> hour	10000 per hour or part there of
5.	21 <sup>st</sup> hour onwards	Rs. 25000 per hour or part there of
