Please find attached copy of the referred Railway Board Letter, **wherein clarification regarding compulsion of online indenting to opt for eT-RR and modification in Forwarding Note was issued as follows.**

- One time registration of customer (i.e. consignor & consignee both) is required for the purpose of availing the facility of eT-RR. However, **on-line indenting is not mandatory for opting for eT-RR. Customer (consignor) can place manual indent and yet opt for eT-RR.**
- Customer is permitted to change details like consignee name, code, destination, bank account details etc., in the Forwarding Note until preparation of Railway receipt. However, number of Forwarding Notes cannot be changed.

In view of the above, all concerned are requested to avail this facility by registering adequate number of Railway Wagon Demands for evacuating the existing cargo from VPT and its terminals stack yards and also to facilitate accommodating cargo received from vessels in pipe line.
