In continuation to the referred circulars, review was once again done with regard to fixation of rate for recovering the cost of Wagon Damage & Deficiency charges and orders were obtained for fixing the rate based on Terminal /System of Wagon Operation for the period from January 2020 to June 2020.

For other category of wagons viz., BCN, BCNHL, BTCS, BLCN etc the Damage and Deficiencies cost will be charged on the actuals sent by the E.Co Railways.

It is to reiterate that the rate per tonne mentioned above will be effective from 01-01-2020 to 30-06-2020, after which the same will be reviewed based on the cost of damages and other charges paid to E. Co. Railways by VPT, in actuals. Any shortfall in the amount collected based on the "Per Tonne Rate" will be included in the subsequent bills, on per MT basis, for arriving at "Per Tonne Rate" in the subsequent bills.

All Port Rail users are accordingly requested to maintain sufficient funds in their respective Port Deposit Accounts.
