In continuation to this office letter 1<sup>st</sup> cited, wherein the Self Reporting Form (SRF) issued by the Ministry of Health and Family Welfare, Government of India was circulated. Now, vide the e-mail 2<sup>nd</sup> cited, Port Health Officer(PHO) forwarded a revised new Self Reporting Form (SRF) duly informing all concerned that, crew members of all incoming vessels on International voyage arriving at Visakhapatnam Port are required to fill up, as part of the Universal Screening of all International Passengers / Crew, the attached Self Reporting Form (SRF) as per the revised Travel Advisory issued by the Ministry of Health and Family Welfare, Government of India.

The said revised new SRF has to be filled in duplicate and one copy each handed over to the Port Health & Immigration officials.

To avoid unnecessary delay at the time of PHO inspection, all Shipping Agents are advised to send a soft copy of the SRF to Masters of incoming vessels with the instruction to have all crew members to fill up the same in duplicate and keep ready in Serial Order as per crew list, at the time of PHO inspection.
