

In supersession to this office Circular 1<sup>st</sup> cited, All the Port Users are hereby informed that reduction in OSBD Norms on pro-rata basis for **all the cargoes** as mentioned below .

In continuation to the circular 1<sup>st</sup> cited, where-in all the Port Users were informed of implementation of Norms for vessels berthed from 15.2.2018. To that affect VPT Board in its meeting held on 31.01.2018 vide its Resolution No.141/2017-18 after elaborate discussions, resolved to approve the Norms for handling of the following Dry bulk(Conv) and break bulk cargoes handled at VPT berths as shown in the table below.

To apply incentive or penalty on the Stevedore on the Royalty paid by them on the cargo handled(Import/Export) on the cargo final bills on the Royalty already paid by them on Import Applications and Export applications in the below manner

S.No.	Incentive/penalties for achievers/Non achievers.	Concession/Penalty
1	Incentive(for OSBD achievers )	50% concession in Royalty
2	Penalty(for OSBD non achievers)	50% Penalty on Royalty

In respect of the stevedoring operation at Fertilizer Berth carried out by M/s Coromandel International Ltd., where there is no royalty as in case of other stevedores the Norm as at Category "F" of the above table the is taken as basis and for instance of non achievement of the same, the penal berth hire charges as mentioned at 2.3.3.(i) of the S.O.R shall be levied on CIL.Hence the OSBDs of vessels above cargoes berthed from 15.2.2018 will come under the purview of said Norms.
