Sub: Revision of Dry-dock charges for ORS Dry-dock with effect from
20-08-2010-Reg

The Dry-dock charges for private vessels are revised w.e.f. 20-08-2010 as per the Secretary/ Tariff Authority For Major Ports, Mumbai order vide reference cited. The charges are as follows.

1) RENTAL CHARGES:

Nature	1 st Day to 14 th Day	15 th Day to 30 th Day	31 st Day onwards
Rental/stayal charges per day for the vessel docked in ORS	Rs. 27,967/-	Rs. 41,937/-	Rs. 55,934/-
Foreign Vessels	USD 995.13	USD 1492.21	USD 1990.25

Other Conditions will apply as per TAMP regulations.

2) DOCK BLOCK PREPARATION CHARGES:

Type of Vessel	Length of Vessel 50 mtrs or Less	50 to 100 mtrs	Above 100 mtrs
Flat Bottom Vessels	Rs. 70,000/-	Rs. 87,500/-	Rs. 1,05,000/-
Shaped Vessels such as Coast Guard/Navy	Rs. 1,20,000/-	Rs.1,60,000/-	Rs.2,00,000/-

Other Conditions will apply as per TAMP regulations.

3) COMPOSITE DOCKING AND UNDOCKING CHARGES:

- i) The Composite Docking and Undocking charges will be levied at US\$ 2117.95 per foreign going vessel and Rs.59,523/- per coastal vessel.
- ii) In case of 2nd Docking, a rate of US\$ 767.22 per foreign going vessel and Rs.21,562/- per coastal vessel will be levied.

4) Block shifting charges will be levied on actuals

The decision of VPT in the apportionment of charges shall be final.
