Sub. Demurrage on cargo not removed from the Wharf- Reg Ref: Minutes of the Board Meeting held on 15-6-2018.

All Port users are hereby informed that Visakhapatnam Board in the Board Meeting held on 15-6-2018 vide Agenda item No.S-21& Board vide its Resolution No.36/2018-19 resolved to modify the wharf demurrage charges levied on cargoes not removed from the wharf in table of the SOR at note 6 under clause 4.6.2.(b) as follows:

Demurrage on cargo not removed from wharf.

Demurrage shall be levied on cargoes not removed from any berth in the Port after completion of discharge from a vessel/shipment to a vessel/Barge.
