Please refer to the letter 1st cited and in partial modification to this office earlier circulars, it is to inform that the vessels with following maximum drafts with required tide can be sailed out from Inner Harbour during night with immediate effect in calm weather conditions.

- i) LOA < 210m. maximum draft 12.00m
(at EQ-1, WQ-1, WQ-2 and WQ-3 berths)
- ii) LOA from 210 to 230m. maximum draft 10.20m
(except EQ-2 (part), EQ-3, EQ-4 berths & OR-1, OR-2 & Fertilizer Berth)

With reference to CE/VPT's letter 2nd cited, it is to inform that the vessels having maximum draft of 11.50m can be handled initially at EQ-8 berth in Inner Harbour during day light hours in calm weather conditions with immediate effect. The draft of vessels will be gradually increased to 12.50m in due course with required tide and calm weather conditions in daytime.

In view of the above, it is requested to nominate vessels accordingly.
