The following pollution mitigative measures may initiated to facilitate VPT in adhering to the directions of the APPCB and Task force team etc., issued from time to time.

1. All bulk cargo stacks to be covered with good quality tarpaulins.

2. Continuous sprinkling of water on stacks and around stacks is to be ensured.

3. Bulk Cargoes shipped/discharged to/from vessels are to moistened to avoid emission of dust.

4. Bulk Cargoes loaded into trucks are to be properly leveled and covered with tarpaulins to avoid spillages on roads during transit.

Speed limit of the trucks/dumpers shall be 10 KMPH.

6. Avoid damage to the sprinkler structures / truck tyre washing facility etc.,

Arrange tarpaulins while discharging bulk cargoes.

8. APPCB vide order cited informed the Continuous online Ambient Air Quality Monitoring (CAAQM) stations would be working 24X7 and the data will be uploaded to both APPCB and CPCB websites and displayed to the public at respective locations continuously.

These instructions are to be strictly adhered to avoid adverse remarks from the APPCB Authority.
