It is to inform that SS ( Rev) Sub module through Port Operating System (POS) ERP system is functional and the Module has gone Live w.e.f. 09.02.2017 duly observing the functionality.

Hence, all the trade members are requested to submit applications for allotment/ surrender of Open/Covered accommodation and miscellaneous allotment not less than 48 hours in advance in SS (rev) module of POS Application. This will help in simplifying the billing system apart from transparency and rendering efficient services to the esteemed customer.


