Sub: Extension / Withdrawal of concessions on vessel related charges for container vessels- Reg.

Ref: - Agenda Item No. S - 9 and Resolution No. 60/2017-18.

All Port users are hereby informed that Visakhapatnam Port Trust Board, vide its Resolution No.60/2017-18 dt.04.09.2017 cited, has resolved to approve/ratify on the following concessions:

- 1) To ratify the action taken for withdrawing 70% concession for the vessels giving direct connectivity issued vide circular No.784, Dt.07.08.2017 in respect of vessels which call at VPT on or after 04.08.2017 duly overriding the earlier board resolution no.113/2016-17 and circular No.703, Dt.1.11.2016 which is valid up to 30.09.2017.
- 2) To extend 70% rebate on Port dues and Pilotage on container vessels where the service is giving direct connectivity, to the ports not covered by existing lines for a period of first 6 months only from the date of first call to VPT of such new service by the line.
- 3) To extend 50% rebate for a further period of 6 months, w.e.f.01.10.2017 up to 31.03.2018, on Port Dues and Pilotage for vessels having less than 50,000 GRT.
- 4) To withdraw the concessions extended vide circular no.752, Dt.11.04.2017 in respect of transshipment container vessels i.e. item no. (b) & (c) of the circular from the date of Boards resolution. and
- 5) To extend 70% rebate for a further period of 6 months, w.e.f.01.10.2017 up to 31.03.2018, on Port Dues and Pilotage for the vessels having GRT more than 50,000.

The above concession at item No.2 will be processed basing on the documents issued by Customs Department or M/s. VCTPL regarding authentication as a new line.
