~~Position~~ Declaration of EQ-3 to EQ-5 Berths as Non-Crane berths due to withdrawal of 10T/15 Ton capacity ELL wharf cranes at EQ-3 to EQ-5 berth from cargo handling operations-Reg.

Ref: - This office circular No. 785, Dt.08.08.2017.



Further to the above circular cited, it is to inform that as the 10.T./15.T Electrical wharf cranes provided at EQ-3 to EQ-5 berths have been decommissioned.

The VPT Board vide its Resolution No. 51/2017-18, Dt. 04.09.2017 has approved the following:

- a) Henceforth EQ-3, EQ-4 & EQ-5 berths be treated as a non-crane berth and berth charges for vessels will be rendered as for non-crane berth.
- b) The Board Resolution No.192/2016-17 will be implemented duly treating EQ-7 as a H.M.C mandatory berth and charged at non-crane berth hire rates
- c) The vessels at EQ-6 shall continue to be charged at crane berth rates irrespective of the fact whether the electric crane has been used or not as was the practice at other shore crane berth all these years.
- d) However, whenever the H.M.C operator expresses his inability to handle any bulk cargo for vessels berthed at EQ-7 and when such vessels have to resort to using ELL Wharf cranes duly shifting them from EQ-6 berth such vessel shall be charged as at crane berth hire rates.

Hence, all the Trade members/Cargo handling operators are hereby informed that the earlier circular issued vide Circular No.785, Dt.08.08.2017 stands cancelled.
