## CIRCULAR No- 770

Sub: Carriage of Laptops/ Cameras/Dongle inside Dock area on Board ship – Reg Ref: DG Shipping, Ministry of Shipping Ir. No. ENG/PSC/Meetings/2017, dt. 21.4.2017.

In order to, to mitigate the difficulties faced at the entry gates of the Dock Area for carriage of Laptops, Cameras, Dongle etc., the following Standard Operations Procedures (SOP) is adopted, so as to avoid inconvenience, and streamline the gate Entry/Exist procedure:

- The concerned carrying Laptops/ Cameras/Dongle inside the Dock Area should make an entry in the Register held at the respective gate duly giving the details about the model and No. of Laptops, Cameras, Dongle etc., so that the same to be verified at the time of the Exist.
- 2. The details are to be registered at respective gates and there will be no separate passes required for the Laptops, Cameras, Dongle.

  The above SOP is for the usage of Laptops, Cameras, Dongle for attending to on-board ship to facilitate/promote E-Governance/E-Business/E-Verification being carried out by Government Officials & associated personnel and various Inspections agencies duly observing all the Security and safety requirements of Port/Indian Navy.
