In continuation to this office Circular 8th Cited, it is to inform that Ministry of Ports Shipping & Waterways, vide reference 9th cited have extended the rationalized tariff for Cruise vessels, for one more season staring from 1st October,2023 to 30th September, 2024 and the Head tax per passenger will be applicable @ \$6 instead of \$5.

Accordingly the rationalized tariff as informed vide earlier trade circular no.1379, dt.08.06.2021 stands valid till 30.09.2024, with the Head tax per passenger @ \$6 instead of \$5.
