Upper age limit is relaxable to the extent of 03years for OBC candidates and 05 years in the case of ST/SC candidates will be allowed. The SC/ST candidates have to submit their latest caste certificate. The OBC Candidate have to submit the caste certificate regarding their OBC status as well as exclusion from creamy layer in the latest proforma prescribed by the Central Government. The upper age limit is also relaxable for Government Servants as per extent rules. The SC/ST/OBC candidates have to submit the latest caste certificate.

If no reserved candidate belongs to ST/SC/OBC community responds, then the candidature of Unreserved candidates will be considered being a rare category and if selected, he will be purely appointed on temporary basis pending fulfilling the ST/SC/OBC backlog point.

Candidates, if appointed will be governed by the New Pension Scheme, which came in to force w.e.f 01.01.2004 and other Rules and Regulations of Visakhapatnam Port Authority. Details will be intimated at the time of appointment.

The crucial date for determining qualification, experience shall be date of Employment Notice i.e dt. 02.02.2024.
